HIGHLIGHTS

- The mortality were: 60 and 67 years old female Bahraini Citizens.
- Royal Humanitarian Foundation (RHF) received a donation of BD 20,000 from Bahrain Tabreed, as a contribution to the "Feena Khair" Campaign to mobilize efforts to support people affected by COVID-19.
- Ministry of Education, in cooperation with the Ministry of Health, paid field visits private schools to ensure that all precautionary measures were enforced to combat coronavirus.
- Based on a parliamentary proposal to face COVID-19 pandemic 'exceptional circumstances', Landlords may be prevented from evicting tenants if they cannot pay their rent during this time.

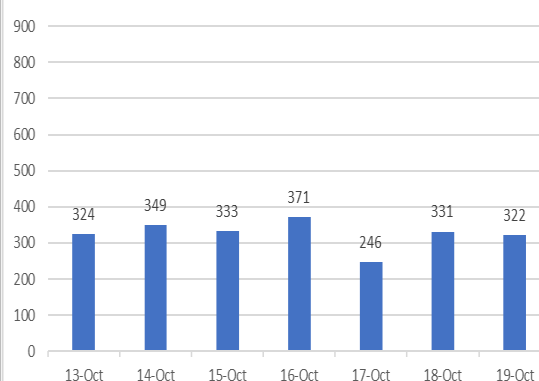

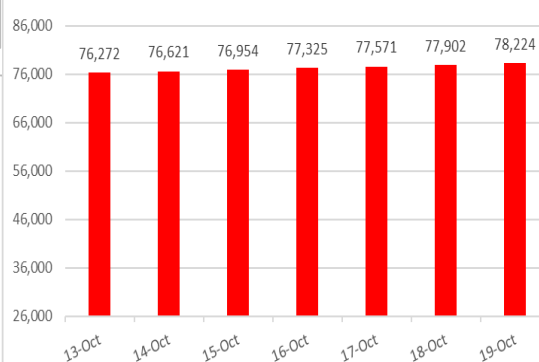
