Situation Report No. 64 - Kingdom of Bahrain

Data as reported by national authorities by 23:59 local time 31 May 2020

HIGHLIGHTS

- Approximately 316,800 PCR tests were conducted.
- 605 newly confirmed cases, bringing total to 11,398.
- At present there are 4,696 active cases, 13 of them in critical condition; 6,683 individuals were discharged.
- 3 new mortalities bringing total to 19. The last 4 mortalities reported are for 3 nationals, ages 59, 70 and 88 and one expatriate 42 years old.
- Extending working hours in fish market (from 8 am to 6 pm) to reduce crowding.
- Last week, Supreme Council of Health opens a 814-bed facility in Aali for isolation and treatment of asymptomatic COVID-19 cases
- MoH urges the rapid reporting of COVID-19 symptoms to receive treatment, mentioning that late reporting was among the reasons of death of the last 4 fatalities.
- Health Ministry publishes guidelines for salons, barber shops and beauty parlours on 26th of May.
- WHO released two new documents: key planning recommendations for mass gatherings in the context of COVID-19; and, technical guidance for the prevention and control of COVID-19 across long-term care services (see links below).

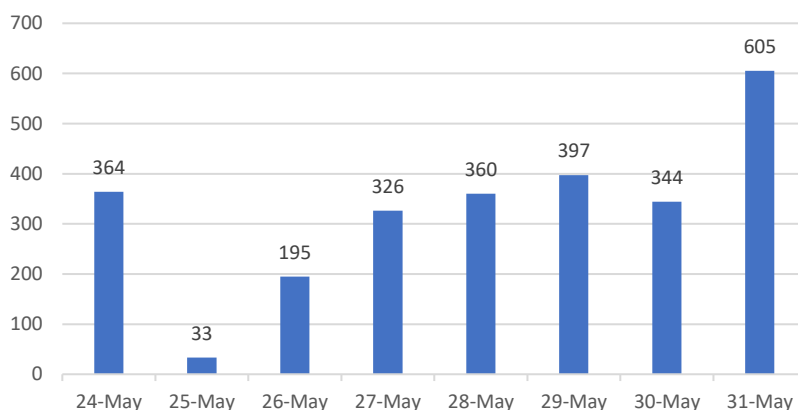
