Situation Report No. 68 - Kingdom of Bahrain

Data as reported by national authorities by 23:59 local time 06 June 2020

HIGHLIGHTS

- Approximately 361,400 PCR tests were conducted.
- 1,568 newly confirmed cases in 3 days, bringing total to 14,383.
- At present there are 5,303 active cases, 14 of them in critical condition; 9,056 individuals were discharged.
- 4 new mortalities, the mortalities were a 66-year-old female Bahraini national and 3 male expatriates 34, 46 and 48 years-old.
- Asymptomatic active COVID-19 cases will now have the option to self-isolate at home starting on Sunday 7 June. Guidelines were provided which includes daily follow up.
- Schools return tentatively on September 16th, remote or in-person education still to be decided, however, first semester courses are being completed for remote education.
- The Information & eGovernment Authority (IGA) Chief Executive highlights Bahrain's pioneering use of healthcare robots.
- Bahrain police book 450 people for failing to wear masks and fines 6 for breaching domestic isolation.
- WHO updates guidance on the use of face masks in context of COVID-19 (see link below).

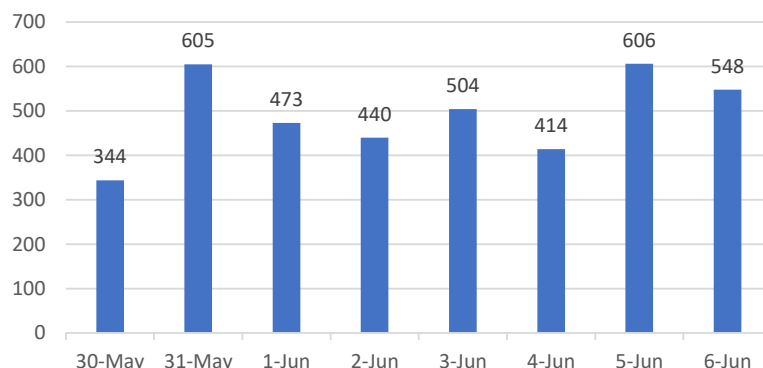
