Licence to Publish

The Eastern Mediterranean Health Journal (EMHJ) requires every author of each paper being submitted for publication to grant an exclusive licence to publish to the journal to ensure international protection against infringement of copyright, particularly unauthorized copying, digital distribution, and other use by third parties, and to enable the journal to handle requests by third parties to reproduce contributions or parts of contributions in any edition of the journal. If the copyright to your work is held by your employer, please obtain the employer's express authority to grant an exclusive licence. If you are a government employee, please obtain express authority to grant a non-exclusive licence to publish and exploit subsidiary rights.

In consideration of the publication in EMHJ of my/our contribution titled:	

I/we hereby grant EMHJ for the full period of copyright including any renewals or extensions throughout the world and in all languages exclusive licence to publish the above contribution or permit others to do so in print and digital formats, including online and network editions of the journal and in other derivative or collective works, and to exploit subsidiary rights in the contributions, including database rights.

I/we confirm that I/we are the sole authors of the contribution, which is my/our original work. I/we confirm that this work has not been previously published in whole or in substantial part. I am/we confirm that copyright to the work does not belong to anyone else and that I/we are expressly authorized to grant this licence to publish.

In return for granting exclusive licence, the contributor(s) (or, if copyright is vested in the contributor(s)'s employer, the contributor(s)'s employer) shall have the following rights:

- The right to reproduce a reasonable number of copies of the contribution, by photocopying or downloading from the EMHJ website, for personal or professional (non-commercial) use. This use includes the contributor(s)'s own teaching purposes.
- The right to post, with the necessary acknowledgement and link to the EMHJ website, the contribution on the contributor(s)'s own, or the contributor(s)'s institution's website.
- The right to publish with the necessary acknowledgement all or part of the material from the published contribution in a book written or edited by the contributor(s). This does not apply to multiple contributions in the same journal, for which permission must be sought.
- The right to use selected figures, tables or illustrations and selected text (up to 250 words) from the contribution for incorporation within another work written by the contributor, which makes part of an edited work published in print or digital format by a third party.
- The right to include the contribution in a compilation for classroom use (course packs) to be distributed free of charge to students at the contributor's institution, or to be stored in digital format in data rooms for access by students as part of their course work and for inhouse training programmes of the contributor(s)'s employer. This does not apply if any charge is made for the compilation (other than photocopying costs) or the training programme.
