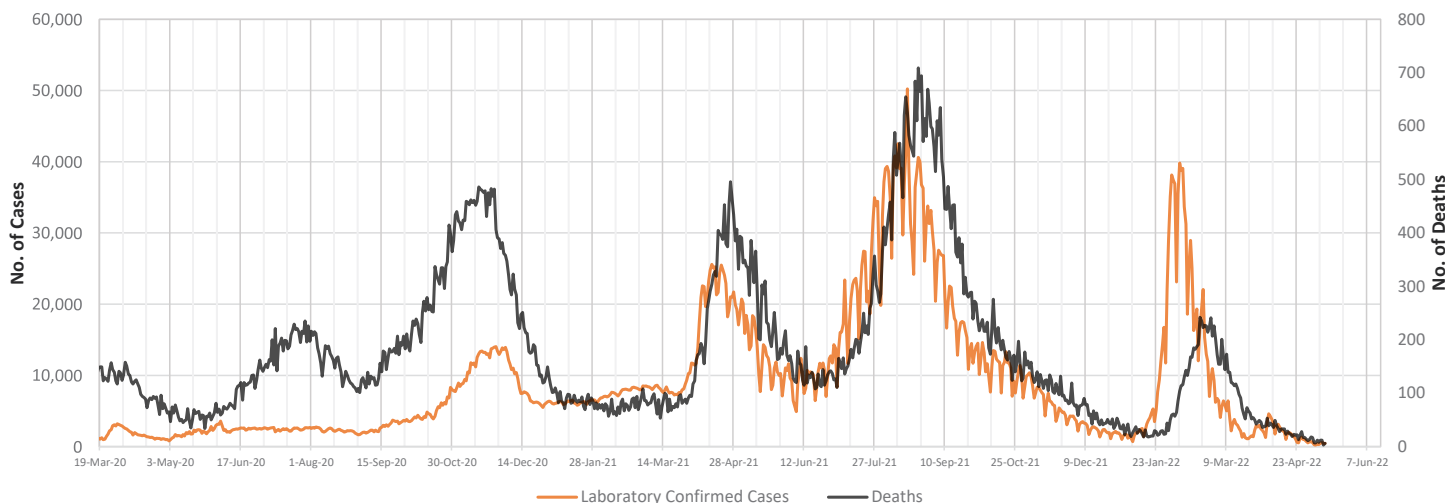

Figure 2 - COVID-19 Patients in Intensive Care, 26 March 2020 - 11 May 2022

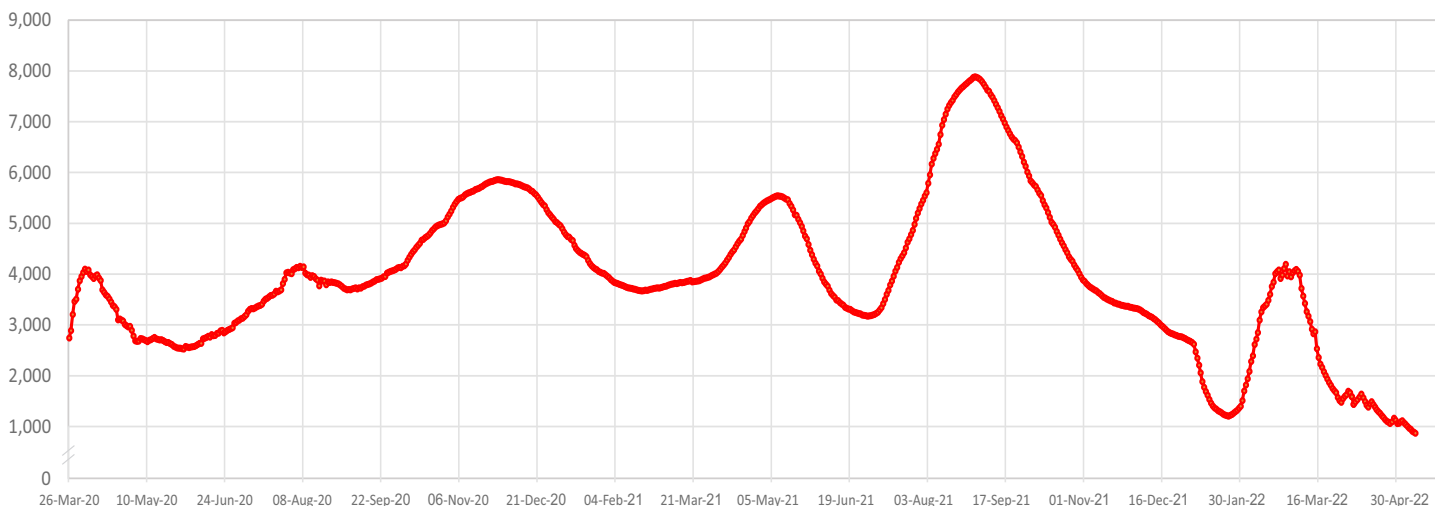
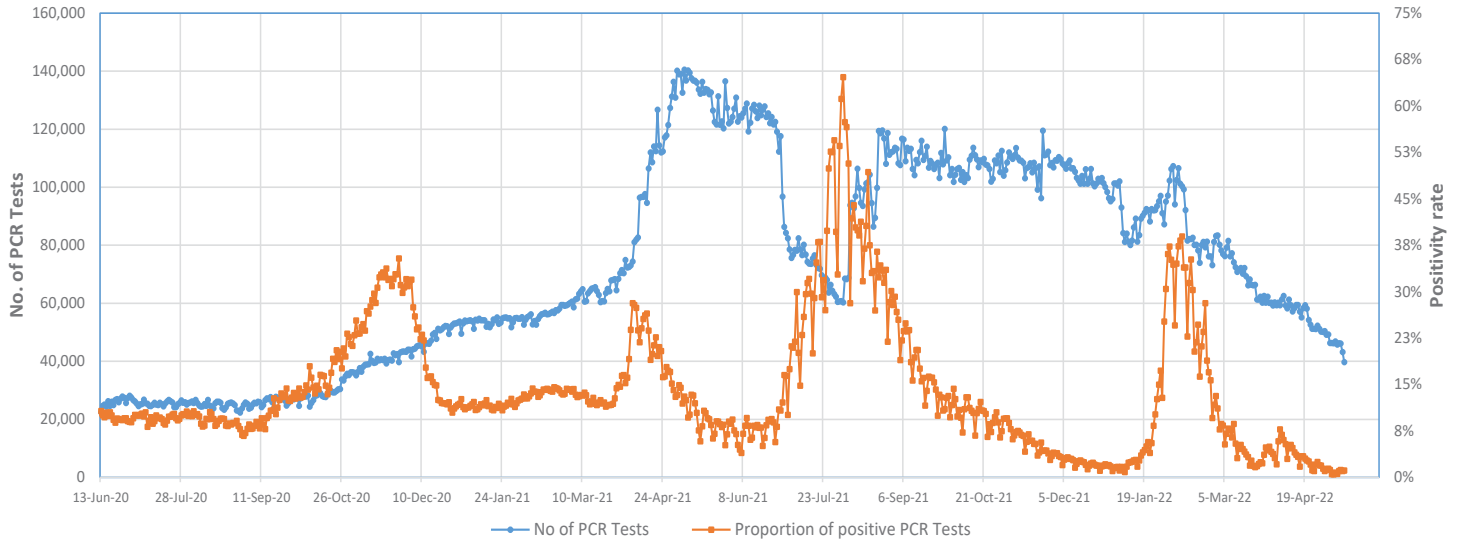


Figure 3 - Number of Daily COVID-19 PCR Tests and Percentage of Positive Cases, 13 April 2020 - 11 May 2022

If the number of admitted COVID-19 patients in a city is <2 per 100,000 populations per day, the status of that city will be **blue**; if the number is ≥2 and <4 per 100,000 populations, the status will be **yellow**; if the number is ≥4 and <6, the status will be **orange**; and if the number increases to ≥6, the status will be **red**.


Imposed National and Provincial Restrictions

As a patient-tracking measure, all citizens are required to be in possession of their national ID cards as a prerequisite to gain entry to government offices, receive public services, or use public transport. Technical Deputy of Ministry of Health Environmental and Occupational Health Center announced that

reception halls are allowed to operate in cities of blue and yellow status. The maximum number of participants allowable in a hall is 75 people in blue cities and 55 in yellow ones. However, in outdoor halls the maximum capacity may be twice these numbers. The maximum duration of events is 3 hours.

Public office employees should get fully vaccinated or provide a negative PCR test result every 2 weeks to be able to attend work.

Travel Restrictions Imposed by Iran

(Updated on 11 May 2022)

Highlights:

Currently the restrictions/requirements for incoming passengers based on countries are as follows:

Ordinary countries	All countries	Certificate of at least 2-dose vaccination (at least 2 weeks after the 2nd dose has to be spent for travel) and negative PCR for Covid-19 is necessary. Syndromic surveillance is performed on arrival and if symptomatic, PCR is repeated (cost is borne by traveler)	N/A

General restrictions:

Except the excluded passengers, all arriving passengers must have an official proof of vaccination and negative PCR test result issued at most 72 hours prior to their travel to Iran regardless of duration of stay overseas. The test result must be in English or stamped and confirmed by Iranian consulates. Iranian citizens who left Iran before 4th of April and passengers coming from Iraq need a negative PCR test result issued at most 72 hours prior to their travel to Iran or vaccination certificate. Nationals of Afghanistan without vaccination certificate must take the vaccination upon arrival.

Passengers above 12 must have a vaccination certificate showing that they are fully vaccinated at least 14 days and at most 9 months ago. After this time, they should have a booster dose.

Passengers must have an e-visa confirmation.

E-visas can be obtained before departure at http://e_visa.mfa.ir/en/

Passengers must have an e-visa confirmation.

All arriving passengers would be subject to medical screening and clinical assessment and in case of showing symptoms would be tested again. The passenger will be quarantined in assigned locations until receiving the test result and in case of positive test result, the passenger will be accommodated in assigned

quarantine locations for 14 days. Passenger shall incur costs for the test and accommodation. (IKIA Information Center)

All arriving passengers are required to fill out “COVID-19 Self Declaration Form” before arrival provided by the airline operators prior or during the flights and hand over the completed forms to the Airlines’ agents. Iranian citizens without full vaccination certificate, no PCR in hand will be in temporary quarantine until the PCR test is ready. Iranian coming from VOC (variant of concern. For now, Omicron, Countries need 14 days quarantine and 2 PCR test during the period.

Wearing masks at all passenger terminals of Iran airports is mandatory.

Passengers are strongly advised to cross check with their air operators on the latest prerequisites and required documentations regarding negative COVID-19 test result or health certificate. Imam Khomeini International Airport (IKIA) office can be reached at +9821 5100 111 regarding the issues related to health regulations both for incoming and outgoing flights.
