• Municipality had shut down 10 stores in Hawally in July for violating mitigation measures and issued 23 fines and 2,405 warnings.

• As a result of the cabinet's meeting, 31 countries ban list to stay until further notice.

• Decisions will be discussed tomorrow regarding curfew hours and transition to the fourth stage of the gradual return to normalcy.


• 11,000 passengers departed and 6,848 arrived since August 1.

• MoH adopts new guidelines to cover medical consultations for the field hospitals due to an increase in the hospitals' bed capacity.


