- The fourth phase of return to normalcy plan which will start on 18 August includes: sports clubs, gyms, barbershops, beauty salons, health resorts and tailors.
- A 50 years old Egyptian doctor who was one of the first doctors to volunteer to combat coronavirus passed away from coronavirus.
- All types of entry visas to all nationalities are not granted without the approval of COVID-19 Emergency Ministerial Committee.
- Evacuation of 1,000 Indian citizen per day from Kuwait as per "Air Bubble" agreement, airlines will fly to 9 Indian cities from August 13 to 17.
- Ministry of Interior: 120,000 violators of the residence law who have not taken advantage of the amnesty period given to leave without paying fines.




