HIGHLIGHTS

- The Cabinet decided to continue the ban list of 31 countries from where travellers are prohibited from entering Kuwait until further notice.
- Embassy of Kuwait in Bahrain: Self-isolation for 10 days for those coming to Bahrain.
- No transfer or renewal of residency visas for expatriates 60 years and above.
- Expatriates who travelled outside the country on September 1, 2019, will be permitted to return despite spending time abroad for more than 6 months.
- Environment Agency will participate today in the first ministerial meeting on the Corona pandemic in Bahrain.
