HIGHLIGHTS

• 851 new cases bringing total to 27,043; of the new cases 279 (32.8%) are nationals.

Data as reported by national authorities by 23:59 local time 31 May 2020

- Infected cases by health area: Al Farwaniyah (279), Al Ahmadi (214), Al Jahra (139), Hawally (117) and Capital Area (102).
- All new cases are contacts of cases or are under investigation.
- 7 new mortalities, bringing total to 212.
- 15,445 cases remain under treatment, 200 of them are in ICU.
- Recovery of 1,230 cases bringing total recovered to 11,386.
- 3,349 new PCR tests conducted bringing total to 293,362.
- Kuwait started the 1st phase of the easing process which will be in 5 phases, each lasting for 3 weeks, to return to normal life tentatively by mid of September.
- Kuwait army troops deployed to impose complete isolation of Al Farwaniyah, the most densely populated district in Kuwait.
- WHO office in Yemen issues a press release thanking Kuwait for supporting delivery of medicines, fuels and drinking water to 109 health facilities in Yemen.
- WHO released two new documents: key planning recommendations for mass gatherings in the context of COVID-19; and, technical guidance for the prevention and control of COVID-19 across long-term care services (see links below).




