Ceasefire - Situation overview

- Access to health services in the affected areas slowly improving: o Hospitals: Bint Jbeil and Salah Ghandour – soft opening. Mays El Jabal is still closed.
- A total of **21** new injuries and **4** deaths related to the war have been reported from 16 to 25 February 2025.
- A total of **162** attacks on healthcare were reported since the conflict started 8th Oct. 2023.. These attacks have resulted **241** fatalities of health workers, **296** injuries of health workers **45** impacted health facilities and **104** impacted medical transport.

Population movement:

- No major changes from the previous week. Source: IOM Displacement Tracking Matrix.
- Displaced people: estimate **950 652** people who were displaced within Lebanon returned in their cadaster of origin returnees, **98 999** remain displaced. Between 8 December 2024 and 18 February 2025, Lebanon's Disaster Risk Management Unit (DRM) reported around **89 400** arrivals from Syria in Baalbek Governorate, including **31 800** people sheltering in **186** informal collective sites and **57 600** living within host communities, among them **20 000** Lebanese returnees (UNHCR).

Health needs and response

- **Public Health Emergency Operation Center** is still coordinating the emergency response and referral of the injured patients. The staff are also managing the emergency stock by ensuring the availability of adequate trauma kits, medications and other medical supplies in all hospitals and PHCs.
- WHO continued to support the PHEOC operations including staffing and coordination work.
- **Trauma Care Pathway**
- **Trauma Care** training:
 - The first round of case management training for trauma care was completed in February 2025.
 - The 2nd round of trainings under trauma care pathway is ongoing.
 - Critical and emergency care for nursing in conflict situation: Fourth round completed for 24 nurses. Training of Trainers completed for 23 nurses. Supervision initiated for 4 local trainers in addition to training of 24 nurses.
- **Psychosocial training in conflict situation** (inside hospitals): ToT conducted – training for 19 hospitals for around 400 HCWs.
- TWG coordination work continues including planned distribution for 25 MCM kits and 18 external fixators.
- Preparing for second set of MCM activation drills for 2025.
- **MHPSS/NCDs:**
- **Trainings for hospitals:** rollout of “breaking bad news” and “de-escalation techniques” trainings for Q1 ongoing.
- MHPSS coordination activities continue. Planning 3-day workshop for partners on MHPSS minimum service package in March.
- **Supplies:**
- WHO – DAMCO warehouse: 50 trauma backpacks in stock, 18 fixa-tors in stock.
- Chronic medication program: 83% of the 64 chronic EML available. New YMCA agreement to cover patient contribution to be imple-mented for a 3-month period starting this February.

- Mental health and psychosocial support**
 - In 2025, more than 350 health care professionals in hospitals were trained on basic psychosocial skills including de-escalation techniques and breaking bad news. This is in addition to a 3-day Training of Trainers.
- Continuity of care for IDPs**
 - First aid kits distribution- From 9 to 22 February:
- Baalbek/Bekaa and Hermel:**
 - 184** visits conducted
 - 351** kits distributed
 - 261** education sessions conducted, reaching a total of **4 305** participants.
- Beirut:**
 - 14** visits conducted
 - 18** education sessions conducted, reaching a total of 339 participants.

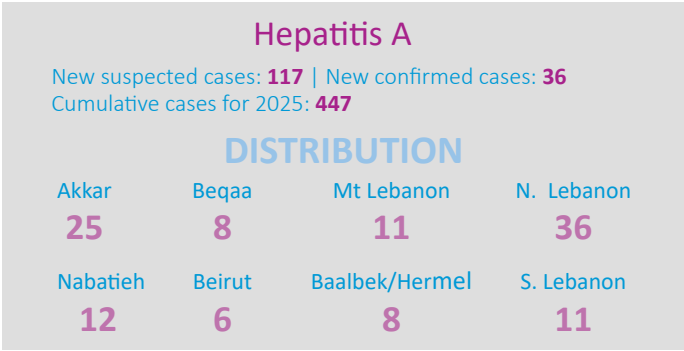
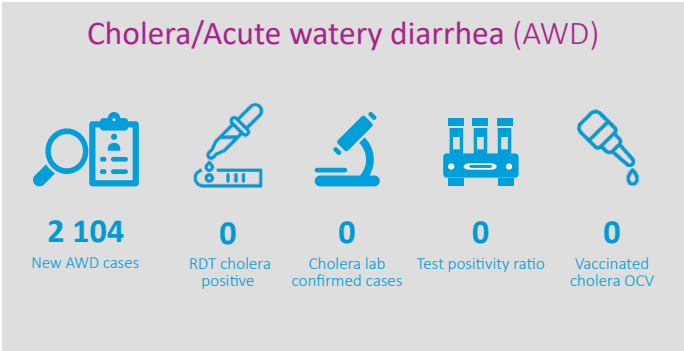
- Gaps and priorities**
 - The Lebanon Flash Appeal has been extended for another 3 months (from Jan to March 2025), calling for additional **\$371.4 million**.

Preparedness and response

- WHO procured and delivered **300** barcode readers for ESU. On the 20th of Feb, 2025: Training on barcode readers for **18** people from the ESU central and peripheral teams to digitize sample identification and follow up.
- Influenza season has started on week 52 of 2024 predominated by H1 followed by B Victoria and H3. Positivity rate for influenza as reported by the respiratory infection sentinel surveillance is 23% for outpatients and 26% for inpatients. As per the pandemic influenza severity assessment, influenza activity has been moderate for the past 2 weeks.

Advancing Primary Health Care towards UHC retreat



Lebanon has made progress in expanding Primary Health Care access and moving towards essential health services packages. These efforts are key to advancing Universal Health Coverage (UHC) and ensuring health for all. The Ministry of Public Health's Primary Health Care department and WHO convened a retreat on reshaping the essential health packages at PHC. Through engaging discussions with key partners in PHC and expert inputs, we developed key recommendations to enhance the packages of care and increase their uptake.

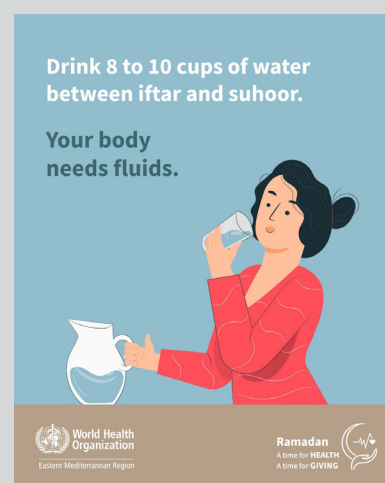

Meeting between the Ministry of Public Health and the Ministry of Finance to discuss NHA reporting mechanism



A productive meeting took place today between the Lebanese Ministry of Public Health and the Ministry of Finance to explore mechanisms for reporting on the introduction and methodology of the National Health Accounts (NHA), facilitated by WHO. This is a key milestone in the ongoing Universal Health Coverage (UHC) project, which is generously funded by the government Luxembourg. The primary focus of the meeting was to establish a streamlined and efficient process for reporting and ensuring transparency. Both ministries discussed the technical aspects and collaborative efforts required to enhance the accuracy of health spending data, vital for advancing UHC indicators and goals. The NHA system will play a crucial role in providing detailed insights into national health expenditure, contributing to better policymaking and resource allocation in the health sector. This initiative is in line with the broader objective of improving data under the National Health Strategy 2030.
