2. Health Cluster Coordination: Health service delivery: Gaps, challenges, Achievements....

The Daily meeting of Jalozai Health Cluster was held here on Thursday in J-3 Health Post of Merlin. The meeting was chaired by WHO-EHA and attended by Merlin, CAMP, CERD and CTC Representatives. DEWS Coordinator, WHO-EHA, KP & FATA attended the meeting. Discussion/Decision are:-

- **❖** A due incident of tents burning happened to electricity short circuit, The tent caught fire very quickly and totally burned within 10 minutes due to the windy storm. At that time two children were in the tent, the parents were outside, both children (males 30 months and 7 months) got serious burn injuries but one was in critical Merlin Team responded very quickly by sending the ambulance and health workers and immediately after giving first aid the two effected children were shifted to LRH Causality Deptt Peshawar along with dispenser but at 3 pm the critical one name Naveedullah age 30 months could not survive and expired. The detail of the Family, Head Gul Khan, having 5 family members (Husband, wife and 3 children). This family having no Registration (New Bara IDP,s) residing with their relatives name Yaseen on the below mentioned address. Phase 6, Sector K, Block 2, Tents 38,39.
- ❖ Merlin's team deployed at Registration Point 1 has limited usefulness, as the point is declared to provide registration to males only. Women and children are transferred to Registration Point 2. Health Cluster decided to support Registration Point 2 with the same team.
- EPI Supervisor remained absent in Health Cluster meeting for two consecutive days. The matter was brought into the notice of EPI Coordinator, Nowshera and UNICEF Health Officer.
- ❖ Health Cluster decided that due to ongoing registration process, there will be no holiday on 23rd March 2012 for EPI Staff working in Registration point.
- Social Mobilization session regarding increased age group of OPV & Routine immunization is planned for CAMP Health Post staff on Saturday at 01:30 PM.
- CAMP observed world water day in collaboration with SSD in jalozai camp phase 2 IRC school. Dr Ikram medical officer CAMP BHU spoke on importance and consumption of clean water in our daily life.

❖ 07 health and hygiene sessions have been delivered to 75 participants by CAMP Health Staff. 1 malnourished child was referred to MERLIN for nutrition. 02 antenatal cases were referred to MCH (CERD) for booking. One case of T.B was referred to T.B hospital, Kacha Garhi ,Peshawar.

A meeting of DEWS Coordinator with Public Health Officer, Jalozai/Nowshera and support PHO, Dr Iftikhar was held at 06:00 PM in WHO-EHA Office. It was decided that:

- ❖ PHO, Jalozai & Nowshera will be preparing the daily report, sharing with DEWS Coordinator and attending the Health Cluster meeting.
- Support PHO (Dr Iftikhar uddin), EHE & Support EHE and Pharmacist WHO will be visiting the Health Facilities in Jalozai Camp.

3. Planned activities

- Assessment of Health Facilities in Union Councils having High influx of IDP's in District Nowshera.
- ❖ Daily basis Health Cluster meeting in Jalozai at 02:30 PM.
- ❖ Daily meeting of WHO-EHA staff of Jalozai & Support PHO & EHE with DEWS Coordinator at 05:00 PM.
- ❖ In collaboration with CERD, CAMP is planning to observe the Mother and Child week in April. Meeting is going to be held at CERD office tomorrow.
- ❖ International TB day is going to be observed at the CAMP health facility.

4. Key issues

EPI Supervisor deployed in the camp is not taking interest in Health Cluster meeting and not providing data.

6. Environmental Health/WASH

- ❖ EH Engineers WHO team held a meeting with the WASH Partners , Health partners, Camp In charge and UNICEF WASH monitors regarding the new IDPs influx in the camp.
- ❖ World water day was celebrated in jalozai Camp in order to create awareness regarding use of safe water as preventive tool for water born diseases. Two different Ceremonies were held in the Camp schools in this regard. Hundreds of students, Parents, staff of schools ,WASH partners, Health partners ,Colleagues from UNICEF,IRC,PDMA and PSU attended these gatherings.EHE WHO team also actively participated in these ceremonies.EHE WHO educated IDPs on the importance of use of safe water and maintaining good hygiene practices.
- ❖ Three new chlorinators installed in the camp on main tube wells in phase 1,Phase 4 and Phase 5.All the chlorinators were tested after installation through residual chlorine monitoring for proper dose management at source and users end.
- ❖ 21 water samples tested for residual chlorine at different delivery points. 15 water samples were found within WHO guidline values. Chlorine dose adjusted for the remaining for proper chlorination.
- ❖ 230 new latrines ,125 Wash rooms, 100 water tanks, 65 Wash pads have been installed for the newly arrived IDPs in Phase 7 and 8.

7. Essential Medicines

❖ WHO EM team performed the assessment of BHU Daag Behsud. Key essential medicines were present except syrup form. Inventory gaps also found as stock out found 15 days (50%) in a month. In the discussions at daily cluster meeting in Jalozai Camp, Essential medicine's stock of all organization found sufficient. 5 EH Packages have been received today from Islamabad and ready to deliver for emergency response at Jalozai Camp anytime.
