

CURRENT EPIDEMIOLOGY OF POLIO IN PAKISTAN

As of 30th April 2015, 22 type-1 wild poliovirus (WPV) cases have been reported in year 2015 from 12 districts/ towns/ tribal agencies/ FR areas (compared to 68 in 2014 from 09 districts/ towns/ tribal agencies/ FR areas). Moreover, WPV-1 has also been isolated from 28 environmental samples in 2015 (out of 103 samples for which results are available) from Karachi (Gadap, Baldia and Gulshan-e-Iqbal towns), Hyderabad, Sukkur and Jacobabad in Sindh; Peshawar and D.I Khan in Khyber Pakhtunkhwa; Lahore and Rawalpindi in Punjab, Quetta and Killa Abdullah in Balochistan and Islamabad. Two sabin-2 like poliovirus cases have been reported so far in 2015 from Khyber agency in FATA.

Following are the key epidemiological characteristics of polio cases reported in 2015:

- 18 (81.8%) polio cases are younger than two years (median age: 13.5 months).
- Based on recall of parents, four (18.2%) cases did not receive any OPV dose (through routine vaccination and/or campaigns); three (13.6%) cases received 1-3 OPV doses, four (18.2%) received 4-6 doses; while 11 (50%) polio cases received 7 or more OPV doses.
- Ten polio cases had date of onset of paralysis in January, ten in February and two in March.

It is worth mentioning that, Pakistan has reported less than one third of wild poliovirus cases this year as per point in time comparison with 2014. Khyber Pakhtunkhwa 40.9% (9/22) and FATA 27.3% (6/22) together reported 68.2% (15/22) wild polio cases in 2015 as compared to 92.6% (63/68) in 2014 at this point in time. No wild polio case have been reported from North Waziristan agency and South Waziristan agency reported only one case this year so far as compared to 73.3% (50/68) polio cases last year for the same time. These findings indicates that the main decline in wild poliovirus cases this year are attributed to these regions of the country. Khyber agency alone reported 22.7% (5/22) of the total wild polio cases so far this year as compared to one case in 2014.

Peshawar contributed 55.5% (5/9) of the wild polio cases reported this year from Khyber Pakhtunkhwa. Moreover; the two environmental sampling sites in Peshawar have also the presence of WPV-1 in five of six samples collected this year for which the results are available. This indicates that, Peshawar district remains the key polio reservoir in 2015. One out of eight environmental samples collected so far this year from Dera Ismail Khan in Khyber Pakhtunkhwa has been reported positive for WPV-1.

The situation in Karachi has been extremely concerning where 23 out of 29 wild polio cases of Sindh province reported from nine towns in 2014. Fortunately, no wild poliovirus case has been reported so far this year from Karachi. However, all the three environmental sampling sites in Karachi



have shown the presence of wild poliovirus in sewage water samples indicating continuous WPV circulation. Wild poliovirus cases reported from Qambar, Dadu, and Sukkur districts; along with the positive environmental samples from Hyderabad, Sukkur and Jacobabad districts in Sindh indicates widespread circulation of WPV and substantial immunity gaps across interior Sindh.

Balochistan province did report 25 wild poliovirus cases in 2014 after an interval of 23 months; of which 19 (76%) cases were reported from Quetta Block (Killa Abdullah, Quetta and Pishin districts). Furthermore, WPV-1 was continuously present in the environmental samples collected from Quetta and Killa Abdullah in 2014. This year, Balochistan reported three WPV-1 cases so far (one each from Killa Abdullah, Quetta and Loralai districts), while no sewage water sample has been turned positive for WPV after January 2015 indicating notable improvement in Quetta Block.

No poliovirus case have been reported so far in 2015 from Punjab. However, WPV-1 has been detected in two out of 15 environmental samples collected this year from five sites of Lahore. WPV-1 has also been detected in one out of six environmental samples collected from the two sites in Rawalpindi. No WPV positive environmental sample has been reported from Multan this year, while environmental samples collected from Faisalabad district have been negative for WPV after 3rd January 2013. In the capital territory of Islamabad, one sample collected in January has been turned positive for wild poliovirus, out of the total three environmental samples for which the results are available so far in 2015.

AN UPDATE ON APRIL 2015 SNIDs

Sub National Immunization Days (SNIDs) for April 2015 have been completed in 75 of 80 planned districts/ towns/ agencies/ areas across the country using bivalent Oral Polio Vaccine (bOPV). The activity could not be implemented in three districts of Balochistan (Quetta, Zhob and Sherani) due to late implementation of March 2015 NIDs. Mansehra district in Khyber Pakhtunkhwa and Orakzai agency in FATA could also not conducted the April SNIDs due to security concerns. Eleven districts of interior Sindh and four districts of Balochistan started the campaign in the second week of April, while 15 towns of Karachi, all eight planned districts of Punjab, FATA except Orakzai agency started the activity in the third week of April. The vaccination activity was delayed until fourth week of April in Lakki Marwat, Swabi, Buner and Swat districts of Khyber Pakhtunkhwa for better preparation.

A total of 251 lots were assessed through Lot Quality Assurance Sampling (LQAS) after the April 2015 SNIDs; of which 166 (66.1%) were of passed quality. Fifty-eight (23.1%) Lots were of intermediate quality from 26 districts/ towns/ tribal agencies/ areas including three districts of Baluchistan, nine of Sindh, five districts of Punjab, six of Khyber Pakhtunkhwa, one of Islamabad and two of areas of FATA. Out of 27 Lots that were of failed quality; 11 (40.7%) were from Khyber Pakhtunkhwa including seven from Peshawar district and one each from Dir upper, Mardan, Nowshera and Swabi districts. Other districts, where the Lots were failed includes four (14.8%) Killa Abdullah district in Balochistan; two each from Rawalpindi and Rajanpur districts in Punjab; two from CDA and one from ICT in Islamabad; four from Karachi district (one each from Karachi North, Gadap, Liaqat and Orangi towns) and one from Jacobabad district in Sindh.

National and provincial level results of Spot survey found 90% or more children finger marked except for FATA (86%). Districts/ towns/ agencies/ areas with sub optimal performance includes Khyber agency (73%), FR Kohat (79%), Mohmand agency (83%), South Waziristan agency (86%), FR Peshawar (87%) and FR DI Khan (89%) in FATA; Korangi town (81%), North Nazimabad town (84%), Orangi town (88%), Site town (89%) and North Karachi town (89%) in Karachi, Sindh; districts Peshawar and Tank (89%) in Khyber Pakhtunkhwa and district Nasirabad (89%) in Balochistan.


Key AFP Surveillance Indicators 2015

Overall AFP surveillance indicators in 2015 so far are above the international standards at the national level as well as in major provinces and majority of districts, towns and tribal agencies (data on pages 3-8).


At the national level the annualized non polio AFP rate for 2015 is 3.73 per 100,000 children below 15 years of age. All provinces and regions except Gilgit Baltistan and Islamabad has the required rate of 2 or above. The indicator is also above the international standards in 88.3% (110/163) of the districts/towns/agencies (map-2). Majority of districts with sub-optimal non-polio AFP rate have small populations and hence low number of expected AFP cases. However, Jamshed, Liaqatabad, North Nazimabad and Site towns of Karachi and Tharparkar district in Sindh, Dir upper, Dir lower, Haripur, Karak, Mansehra, Nowshera and Swat in Khyber Pakhtunkhwa, Bahawalpur, Chiniot, Faisalabad, Khushab, Pakpattan and Toba Tek Singh in Punjab, Bajour and Kurram agencies in FATA, Quetta in Balochistan, Muzaffarabad in AJK and CDA in Islamabad have significant number of expected cases. Eighty two percent of the districts/towns/agencies (109/133) which reported AFP cases had adequate stool specimen collection rate above the international standard of 80%.

All the districts/ towns/ agencies/ areas with sub-optimal surveillance indicators especially those which have persistent low indicators need to review their AFP surveillance system for the causes of low performance and take corrective actions accordingly. Actions to improve the situation and maintaining the status in well performing districts should be part of the district specific plan and should be regularly reviewed.

MARCH 2015 NIDs


The third National Immunization Days (NIDs) of 2015 completed across the country targeting 35.5 million children using trivalent Oral Polio Vaccine (tOPV). Vitamin A supplementation was also given to children above 6 months of age. Vaccination activities completely/partially delayed due to heavy snow fall in three UCs of Neelum district in AJK; two UCs of Skardu and one UC of Astore districts in Gilgit Baltistan; and five UCs of Abbottabad, four UCs of Mansehra and 14 UCs of Chitral districts in Khyber Pakhtunkhwa. The campaign was also delayed in Quetta and Sherani districts in Balochistan, Karachi (nine UCs) in Sindh, Rawalpindi and Jhang districts in Punjab and Islamabad for better security arrangements; and Sukkur (eight UCs), Larkana (one UC), Kambar and Dadu districts in Sindh for better preparations.

Three polio workers and one security personnel were killed in armed attacks during the vaccination drive. Of these, two Lady Health Workers and one policeman were shot dead in in district Mansehra in Khyber Pakhtunkhwa, whereas one polio worker was killed in Bajour agency in FATA. Vaccination activity was stopped in the above two areas following the incidents. It is important to mention that despite the unfortunate killing of vaccinators and security personnel, the NIDs continued in most of the areas of the country and more than 36 million (101%) children have been reportedly vaccinated.

A total of 336 lots were assessed through Lot Quality Assurance Sampling (LQAS) after the March NIDs; of which 218 (64.9%) were of passed quality. Sixty-three (18.7%) Lots were of intermediate quality from 37 districts/ towns/ tribal agencies/ areas including eight districts of Baluchistan, 12 of Sindh, seven districts each of Punjab and Khyber Pakhtunkhwa, two of Islamabad and one area of FATA. Out of 55 Lots that were of failed quality; 26 (47.3%) were from Balochistan including 11 in Quetta, eight in Killa Abdullah, four in Pishin and one each in Jafarabad, Nasirabad and Lasbela. Other districts, where the Lots were failed includes nine in Khyber Pakhtunkhwa (three in Peshawar and one each in Abbottabad, Buner, Charsada, Dir upper, Hangul and Karak districts), nine in Sindh (six in Karachi (Gadap, Gulberg, Jamshed, Layari, Orangi and Saddar towns) and one each in Kashmore, Larkana and Tando Muhammad Khan), six in Islamabad (three each in CDA and ICT), four in Punjab (Rawalpindi) and one in FATA (Mohmand agency).

Market Survey results showed sub optimal performance in Killa Abdullah (78%) and Killa Saifullah (89%) in Balochistan; Khyber (75%), FR Kohat (80%), Mohmand (84%), South Waziristan (85%) and FR Bannu (86%) in FATA; Peshawar (82%) and Dirupper (89%) in Khyber Pakhtunkhwa; Layari (50%), Korangi (82%), Jamshed (83%) Shah Faisal (87%) and Orangi (89%) in Karachi, Sind; and CDA (88%) in Islamabad. The sub-optimal vaccination quality in critical districts/agencies of reservoir regions in FATA, Khyber Pakhtunkhwa, Quetta block (Quetta, Pishin, Killa Abdullah) and the high risk towns in Karachi is of serious concern. It is important to recall that the highest campaign quality is required in the polio reservoirs to stop the viral circulation. At the same time; to avert the risk of viral introduction and establishment in areas without polio cases and endemic poliovirus circulation, the campaign quality maintenance is of utmost importance.
