



INCIDENCE & DEATHS BY DATE




TOTAL CASES & CASES PER MILLION POP.




Pakistan reported **2,459** new cases of COVID-19 on **14 December 2020**. The total number of cases notified since the beginning of the outbreak is **443,246** with **8,905** deaths **(CFR: 2.01%).** Out of the total **48,008** currently active cases **3,057** cases are hospitalized.

MEETINGS & COORDINATION

Today, 15th December 2020, The WHO Country Representative Pakistan Dr Palitha Mahipala inaugurated the three days' workshop on Early Essential Newborn Care (EENC) at Pakistan Institute of Medical Sciences, (PIMS). The main purpose of this coaching is to address major gaps identified through the recently conducted quality of care assessment.

The objectives of this workshop are to build capacity of the core teams from major public sector hospitals on Early Essential Newborn Care and to enable them to implement EENC and to train other relevant staff in major public sector hospitals in Islamabad.

Dr Palitha in his speech gave reference to WHO global guidelines on EENC and emphasized that "Adaption of good practices, Elimination of harmful practices and Revising newborn NICU admission criteria will help in proper management of Newborn cases and will limit the complications of preterm/LBW babies".
