Referrals from Gaza: Summary for March 2012

- A 17-year-old female referral patient from Gaza died while undergoing critical heart surgery at Makassed Hospital, after waiting her permit to cross Erez was delayed. She had missed her original appointment at Makassed Hospital after both of her parents were denied approval to cross Erez in order to accompany her. A second permit application was eventually approved, allowing the mother the accompany her daughter to hospital appointment scheduled two weeks later.
- In March, 94.4% (725 patients) of all patient applications for permits were approved, an improvement over the 2011 average of 90%. However, 9 patients (1.2%) who applied for a permit to cross Erez checkpoint were denied a permit during March, and 34 patients, including 8 children (4.4%), did not receive a response to their permit request before the date of their hospital appointment.
- The main reasons for patient referrals during February were for treatment in the following subspecialties: cardiovascular (17%), oncology (12%), ophthalmology (9%), neurosurgery (6%) and orthopedics (5%). These cases represent 49% of the total referrals and 60% of the estimated total referral cost in March, which was NIS 12 million (\$3.2 million).

Destinations and reasons for referral for medical treatment

During March 2012, the Referral Abroad Department (RAD) of the Palestinian Ministry of Health (MoH) referred 1,295 patients to health facilities for specialized treatment not available in MoH facilities in Gaza. Similar to last month, 22% (284 patients) were referred to NGO or private facilities within the Gaza Strip and 78% (**1,011 patients**) were referred outside of Gaza to hospitals in East Jerusalem (35.5%), Egypt (26.7%), Israel (24.4%), the West Bank (9.3%) and Jordan (4.1%). Of these, 741 patients required permits to access through Erez crossing and 270 through Rafah border crossing (see Table 1, below).

Patients were referred during March mainly for treatment in the following subspecialties: cardiovascular (17%), oncology (12%), ophthalmology (9%), neurosurgery (6%) and orthopedics (5%). These cases represent 49% of the total referrals and 60% of the estimated total referral cost in March, which was NIS 12 million (\$3.2 million). These cases represented 45% of the total referrals last month and 51% of the total cost.

Permit applications for patient referrals through Erez

In March 2012, the Israeli District Liaison Office (DCL) processed 768 patient applications for permits to cross Erez to access hospitals in the West Bank including East Jerusalem, Israel and Jordan (see Table 2) compared with 766 last month and 902 in January 2012. During this month 92.1% of applications (708) were submitted and financially covered by the MoH, 3.3% (26) were self-funded,1.5% (12) by Nour al-Alam Foundation, 1.3% (10) by Peres Center for Peace, 0.9% (7) by Physicians for Human Rights - Israel, and the remaining 5 cases by other funds.

* Approvals are typically communicated to the patient only 24 hours in advance of their scheduled appointments.

** "Delayed" means that the Israeli Liaison Office did not respond to the permit application prior to the patient's hospital appointment date. Some patients in this category may eventually receive permit approval, but after their hospital appointment has passed, and must then reschedule their appointment. Other patients in this category may eventually receive denials or may not receive any response.
*** Requests for interrogation are reported here when communicated by Israeli authorities through the Palestinian Liaison Office. Israeli security officials also contact patients directly for interrogation; therefore the number reported is likely underreported.

In March, **94.4%** (725 patients) of all patient applications for permits were approved, representing an improvement over the 2011 average of 89.7%. Of the remaining 5.6% of all patients, 1.2% (9 cases) were denied permission to cross Erez checkpoint. Four of the 9 denied patients had been referred for orthopedic treatment, 2 for neurosurgery, and one for internal medicine, neurology and ophthalmic. Another 4.4% (34 patients, including 8 children) had their applications delayed beyond their hospital appointment. **Nine patients were called for interrogation by the Israeli General Security Services (GSS) as a condition for their permit application.** Following their interrogation, 6 patients were still waiting for a GSS response, 2 were asked to submit a new request, and one was approved a permit.

Delays in processing applications can be critical for patients who are waiting for urgent medical treatment (see below, case of Shahira Saber Hammad). During 2011, three patients died before receiving permits to travel through Erez crossing to access the hospitals they have been referred to. Since 2008, 70 referral patients were reported to have died before reaching medical care outside Gaza (50 referrals through Erez crossing and 20 through Rafah border crossing).

Young Gaza teenager dies during surgery after waiting two weeks for permit approval

Shahira Saber Hammad, a 17-year-old teenager and a referral patient from Gaza, died March 26 at Makassed Hospital during open heart surgery to repair an atrial septal defect. Shahira had been referred for the corrective surgery by her treating doctor at Shifa Hospital on February 13, 2012, but was delayed in accessing care after her first permit application to cross Erez was not granted.

On February 15, the family received a referral for Shahira to be treated at Makassed Hospital in East Jerusalem, and admission was scheduled for Shahira on **March 11, 2012**. On March 5, Shahira submitted her application to the Palestinian DLO for permission to cross Erez on the appointment day, and listed both parents as possible companions --- for Israeli Authorities to choose one. The Palestinian DLO raised the request to the Israeli side but was informed that both parents were denied and that patient should submit the name of another companion.

After consulting with the family, the Palestinian DLO informed the Israeli Authorities on March 7 that there was no other family member available to accompany her, and so the family was asked to choose one parent to accompany Shahira. On March 12 the Israeli permit office informed the family to reschedule their hospital appointment, which was then arranged with Makassed Hospital for March 25.

On March 22, the Israeli authorities at Erez approved the permit request for Shahira, and her mother as companion, and both crossed Erez on **March 25**. Shahira arrived at Makassed Hospital in a poor health condition and was placed immediately in the intensive care unit; her doctors decided to perform the open heart surgery the next day, but unfortunately Shahira died during the surgery.
