


SITUATION REPORT






Pakistan reported **567** new cases of COVID-19 on **17 October 2020**. The total number of cases notified since the beginning of the outbreak is **323,019** with **6,654** deaths (CFR: 2.06%). Out of the total **9,296** currently active cases, **793** cases are hospitalized, out of which **534** (**67.34%**) are in critical condition. **8,503** COVID-19 positive cases are at designated isolation facilities or inhome isolation. A total of **307,069** (**95.06%**) have recovered and discharged.



Daily COVID-19 Positivity Rate






(Last 24hrs) COVID-19 Positivity rates by Province

Meetings & Coordination

WHO Pakistan in collaboration with the Child Survival Program, Provincial Department of Health Sindh, conducted a four days training on Pediatric case management, critical and intensive care of COVID-19 patients. This training was a component of upscaling the COVID-19 response using a three-pronged approach.

17 health care providers from 10 districts of Sindh province attended the training from 13-16 October 2020. Hands-on training sessions for the participants were conducted at the Civil Hospital Hyderabad.

Dr Irshad Memon, Director General Health Services Sindh and Dr Sara Salman Head of the WHO sub-office Sindh graced the inaugural session of the training.
