HIGHLIGHTS

- 44% of the new cases were female and 11% children.
- Cities with highest new infections were: Makkah (73), Jeddah (65), Hufuf (46), Riyadh (42), Madinah (38), Al Mobarraz (26), Dammam (26), and Hail (21).
- Umrah to resume with limited number of domestic pilgrims; Umrah permit and coronavirus-free certificate are mandatory.
- A joint scientific cooperation between KACST and Noura Medical Services for the molecular detection of SARS-CoV2 virus by creating a laboratory to examine Corona for those wishing and traveling through the Kingdom's airports.
- The Kingdom ranked 2nd among G20 countries in the speed of conducting COVID-19 tests, results take on average of 31 hours.
