

HIGHLIGHTS

- 40% of the new cases are females and 11% are children.
- Cities with highest new infections: Riyadh (62), Madinah (56), Yanbu (25), Makkah (25), Jeddah (22), Dhahran (13), Hufuf (12), Dammam (11) and Hail (8).
- Ministry of Commerce warns that repeated violation of precautionary measures will lead to closure of commercial facilities; and adds that during sale periods, facilities are obligated to extend the sale duration, increase working hours and make products/commodities available for online purchase.



IMPORTANT DEFINITIONS

Definition of a Contact: A contact is a person who has experienced any one of the following exposures during the 2 days before and the 14 days after the onset of symptoms of a probable or confirmed case: **1.** face-to-face contact with a probable or confirmed case within 1 metre and for at least 15 minutes; **2.** direct physical contact with a probable or confirmed case; **3.** direct care for a patient with probable or confirmed COVID-19 disease without using recommended personal protective equipment; OR **4.** other situations as indicated by local risk assessments.
